Termination

Track changes and compliance

The system audits changes in active contracts. It checks for compliance as necessary, according to pre-set business processes. It records the actions of specific users.

Negotiation and authorization

Commenting on the content of the contract and its attributes/data.

Realization

Contract activation, including expiration and effectiveness dates. Setting specific conditions for the functioning of contract-related processes.

Approval

Approval of the contract across the company and also of other participants in all involved parties.

- Using automated processes, we will guide you from the initial request to the contract conclusion. During the process, we automatically inform its participants regarding the progress, and we prompt them to provide the necessary information.
- The concluded and active contract may be terminated automatically when it is no longer active, or we can prompt the responsible employee to prolong the contract. Thus, we help to ensure the continuity of contracts precisely according to company and legal standards.
- For each contract, you have the option of setting your own business controls and business rules both for the contract preparation and for the time following its conclusion. Business protection

- We also use modern technology in the user interface (UI / UX). Therefore the application is accessible from any device.




Compliance

- We understand the sensitive nature of contractual documents; therefore, you can choose the level of confidentiality for each contract. Thus, only those who have the appropriate authorization can access the contract.
- We automatically maintain links between documents created. The 360 ° view of the contract gives you a comprehensive look at the information and materials related to the contract.
- The solution supports linking with ARES or the Public Contract Register of the Ministry of the Interior (ISRS). At the same time, the solution expects the connection to internal or external risk system, which makes it easier to align contracts with legislation and regulations, including GDPR.
- Also, it is possible to redact contracts. For further use of contractual documents (such as publication in the ISRS contract register), you can black out selected passages of the text and, at the same time, remove any confidential information from the document.
